### **Keep Coming Back!**


I left Jefferson City Welcome Home Group of OA ten years ago after attending for about 20. I didn't think the program was working for me (could it possibly be that I wasn't working the program?) I tried an easier, softer way which resulted in a huge physical, mental, and spiritual relapse. When I left so did another OA member who was a good friend of mine – she returned to meetings before I did pointing out that even though I hadn't been perfect in OA before I was still much better off attending than when I left.

When my friend returned I followed soon afterward – by then the group had dwindled to one loyal member who had kept it going week after week. I am very grateful and thankful for her showing up even though at times she was the only one who did. After our return eventually the group grew.

Today we have at least seven regular group members. I believe we have recovery in our group – our members do service by taking turns putting out literature and leading meetings. One member serves as secretary and another as contact person for intergroup and new comers. We have a member who is now volunteering time editing the OA Newsletter.

Service is a very important crucial part of why we have added members. I believe it is because members often stay after the meeting to talk with newcomers as well as doing outreach to them during the week. Some members have asked for someone to take them through the 12 steps and sponsor them.

Realizing this is a program of attraction and we are here to share our experience, strength and hope, I believe our group is stronger and that there is more recovery. *Lois T*.

- Meetings start and end on time.
- Are all attendees, including newcomers, greeted and made to feel welcome and accepted?
- Does the meeting focus on OA recovery through the twelve Steps and Twelve Traditions?
- Do we offer our own experience, strength, and hope, sharing the solutions we have found in this program?
- Is the group contributing financially to all levels of OA service as per our Seventh Tradition?
- Are sponsors available and identified at the meeting?
- Does the group practice anonymity by reminding members not to repeat who is seen or what personal sharing is heard at a meeting?
- Does the group follow a meeting format?
- Is only OA approved literature on display for sale?
- Are group conscience meetings held regularly?
- Are all service positions filled, and is rotation of service practiced?
- Is cross talk and advice giving avoided? -Melanie T, Public Information

Dear Fellow OAs,

I am using my Newsletter article this month to recap the discussion about the recommendation of the Ad Hoc Committee that studied The Intergroup Office Question and the Member Survey results related to the Central Office questions. JMO described how the committee studied the Office question and presented the results of their process and the Member Survey. The committee recommended that our Intergroup should not continue to pay for an office and should redirect funds to other ways to carry the message. The Board of

Trustees unanimously agreed with this finding. The reasons for this recommendation include: a website and social media are currently more important for outreach than having a physical office space; the survey shows most OAs do not visit the office and said their recovery would not be negatively impacted if it closed; very few Intergroups worldwide maintain an office and this does not prevent them from carry out essential functions for their home meetings; and functions that happen at the office can be carried out in other ways.

Questions and discussion followed.
Reps asked - where would all the stuff stored at the office go? Will there be a proposal for alternative ways to provide services currently done at the office. Two members of the committee are researching this and other logistically issues and should have recommendations for our February meeting. It was noted that members of groups that hold their meeting at the office would be inconvenienced by closing the office and that volunteer from Intergroup would assist these groups to relocate should the office be closed, if these groups wished.


How would these "freed up" funds be spent? They would be redirected to efforts to carry the message. Currently our PI (Public Information) Chair is working on a billboard, attending a Missouri State conference of nutritionists, outreach to youth and other efforts. One IG officer pointed out that recent past PI budgets have ranged from zero to \$300. The 2020 PI budget is \$1,500 to fund our primary purpose, to carry the message.

Opinions were also offered: recovery is based on meetings, events, service, fellowship, etc., not things that require a business office; and these recommendations do not represent a group conscience decision, this is a "we" program — the voting members of IG will make the decision about whether to continue renting office space.

#### Here is the schedule:

- 1) In January, all home groups received a copy of the combined report in their January Information (Newsletter) Packet. This report is also available on our Webpage www.oaregion4.org/stlouisoa
- 2) In February, all home groups will receive a report with suggestions on where things would be stored, how and where office functions would be conducted and the financial implication for IG.
- 3) Please make sure to have a group conscience to review and discuss these reports and decide how you would like your Intergroup Rep to vote at the March 8 Intergroup meeting.
- 4) A two-phase vote will happen, first voting members (IG reps, officers and committee chairs) will vote to keep the office or close the office. If the IG group conscience is to close the office, then relevant changes in our By Laws Article XII, Section 9G. and our Policy Manual, Section A will be voted on. Both phases will follow Roberts Rules of Order.
