Old Business:

- 1.) March 2020 Motions and Proposals: I make a motion to table the two (2) proposed bylaw and policy and procedures changes remaining from our March meeting. They are changes that will result from the passing of the motion to close the IG business office/meeting space and can wait until our annual November Business Meeting. Is there a second? Pro/Con discussion? All in favor. All opposed.
- 2.) Report out Survey Results for Communication Q1, Q2 and Q3. Please review these reports on our Webpage.

New Business:

- 1. BOT recommendation to not re-open office meeting space due to extended Stay at Home Order from St. Louis County. Even it that order is lifted, social distancing of meeting participants is impractical given the physical dimensions of the meeting space. Also, we are not in a position to deep clean and sanitize the space four (4) times a week, nor can we afford to have a professional company perform this task. We believe the former estimation for a six (6) month transition (March thru August) be changed, and that the BOT should proceed to implement a new plan to terminate our lease by July 31, 2020.
- 2. Updated transition timeline: Sue our business manager will transition to a home office by May 17. PO box will be obtained at Afton Post Office and mailing forwarding and change of address will begin June 1. Obtain cell phone and terminate Charter/Spectrum phone/internet by June 15. Give notice to landlord June 1. Organize/pack/discard during month of June. Obtain storage facility and move records/literature/etc. to storage facility by June 30. Set appointment times for members/groups to pick up their materials including members who made donations they would like returned during July 1-24. Donate anything left by July 31. Obviously there is a lot of detail in each of the above; the intent here is to be transparent.
- 3. We have been announcing that our IG BOT needs a Secretary. Our interim volunteer is stepping down as of May 31. A secretary needs to have: one (1) year of abstinence, word processing skills, a computer, internet service, and being willing to take minutes of key discussions and resolutions at our IG meetings (9 per year) and formal

BOT meetings (usually 2-3 per year). Also, our BOT typically meets informally between IG meetings to review the Chair's proposed agenda and discuss any issues/concerns brought to their attention. The Secretary also proofreads the Newsletter and forwards it to the printer/or currently distributes it electronically. Lastly, the secretary electronically distributes meeting minutes, and other reports about a week before the IG meeting. The time commitment is approximately 20 hours a month.

- 5. Heads up, although it is only May, our November Business Meeting is really just a few short months away. Since it is an even year the following officer positions will be open Vice Chairperson, Treasurer and PI Officer. Please prayerfully consider if any of these service opportunities may enhance your recovery.
