St. Louis Bi-State Intergroup Minutes

February 12, 2023 1:30 p.m.

Open: The meeting was called to order by Chair, Dianne S. at 1:30 p.m. Zoom recording feature enabled for the duration of the meeting. All members were informed of the recording process.

Communications: Meeting was held via ZOOM. Members were instructed on meeting ID and Password via email. Representatives were notified via email the agenda, previous meeting minutes, and committee/service reports.

Readings: Serenity Prayer, The Twelve Steps, Tradition 2, Concept 2

Welcome: 20 members in total were in attendance; all via ZOOM. Four BOT members, six committee chairs, 10 IG representatives, and no visitors. 20 eligible voters and a quorum was confirmed.

Minutes: January 8, 2022 minutes were distributed via email for review prior to the meeting. One minor typo to be corrected on page 2 under Workgroups: Fall Retreat: misspelling of "made." Minutes were approved once the correction was complete.

Reports: Chairperson and committee reports were distributed via email for review prior to the meeting. The following comments are in addition to the distributed reports:

- J-MO updated members on the format and content of Unity Day scheduled for February 26, via Zoom.
 Representatives encouraged to announce event at all meetings throughout February.
- Treasurer, Marina F clarified a question asked by a member during the January budget presentation for 2023. Under Professional Fees are the following categories and their fees:
 - Accounting Fee is the cost of our paid bookkeeper
 - Merchant License Fee is the annual fee of Not-for-Profit status in Missouri
 - Secretary of State Annual Registration is the personal property fee required of non-profit organizations
 - Web Consultant is fee for ongoing web support
- Vice-Chair, Elizabeth C updated the representatives on the progress of the Google ad supported by IG funding as 80% of the visitors to the St. Louis Bi-State Area website were from the Google ad.
- Vice-Chair, Elizabeth C requested anyone wishing to make an event flyer consult with her first to streamline the process of information required on flyers.
- Chair, Dianne S notified the representatives of a need to fill a service position mailing the monthly newsletter to
 members not able to obtain the information electronically. The individual previously fulfilling this duty has
 stepped down. Members having interest in performing this monthly service will contact Dianne S for further
 information. It was confirmed that the postage and supplies needed to complete this service are reimbursable
 by the Intergroup funds.

Seventh Tradition and Roll Call: Participants were documented and signed in by vice-chair. Representatives were encouraged to be responsible to contribute for Seventh Tradition. Due to updates with the website, members were informed the seventh tradition on-line feature is currently not functional. Web consultant is working to resolve this issue as soon as possible. The mailing address was confirmed to be P.O. Box 28882, St. Louis, Missouri 63123-0082 and shared with all members via the chat feature.

Intergroup Reps Home Meeting Comments:

- Reminder that the Webster Groves, Saturday 10 am meeting is now hybrid and welcomes in-person attendance as well as Zoom participants.
- Potential new meeting starting in the Wentzville, MO area. More information to come in the future.

New Business:

- World Service Business Conference (WSBC) Agenda Questionnaire: Chair reviewed the purpose and privilege of all OA Intergroups to be involved in the task of what topics, proposed business motions and amendments to OA bylaws will be discussed at the World level. The proposed changes have been reviewed by Cyndy L, 2023 WSBC delegate and Christina D, then presented to the Board of Trustees (BOT) for approval. Once the BOT agreed to the delegate's recommendations, the body will now discuss and vote on which items the St. Louis Bi-State Intergroup feels are of relevance to WSBC discussion and review. For the complete explanation of the content of 2023 agenda questionnaire, please refer to World Service Business Conference Overeaters Anonymous (oa.org). All Intergroup representatives were provided the motions and rationale for each prior to this meeting via email. Prior to the formal presentation, the following was established by the Chair:
 - Number of voting body: 20
 - Quorum was confirmed
 - o Parliamentarian was J-MO
 - Volunteer Timer was Jeremy C

Cyndy L divided the proposed motions into three categories for review (see attachment for summary):

- Consent Agenda 1 to send forward for discussion at WSBC
 - New Business Motions (NBM) A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, P, Q, R
 - Bylaw Proposals (BP) 1, 2, 3, 4, 5, 6, 8, 9, 10, 11, 13, 16
- Consent Agenda 2 to NOT send forward for discussion at WSBC
 - NBM S, T, V
 - BP 7, 12, 14, 15, 17
- Motions to discuss within the St. Louis Bi-State IG as to if the body feels the motion should be discussed at WSBC
 - NBM U
 - NMB T (pulled from consent agenda 2)
- The voting body was asked for objections to consent agenda 1. No objections were voiced, but a comment was documented to be passed on to WSBC regarding NMB R and NMB I. Cyndy documented the comments to be added. The body held a formal poll to vote on this consent agenda.
 - 20 out of 20 voters agreed to send Consent agenda 1 forward for discussion at WSBC
- The voting body was asked for objections to consent agenda 2 to NOT send forward for discussion at WSBC. One objection was voiced to remove NMB T for discussion within the body. No further objections were voiced. There was one question regarding NMB V and answered by Cyndy L. The body held a formal poll to vote on this consent agenda
 - 20 out of 20 voters agreed to send NOT send Consent agenda 2 forward for discussion at WSBC
- Cyndy L led discussion regarding NMB T and provided the first Pro statement regarding moving this item forward for discussion at WSBC.
 - Parliamentary procedure was followed. Timer was initiated and each speaker allowed 2 minutes for each Pro and each Con statement, alternating between pro and con for a total of three each. Questions were allowed after the pro/con statements.
 - The question asked before voting was if this IG doesn't move this forward, other IGs may find it needs to be discussed and so it may make it to WSBC anyway?

Answered as confirmed. The majority of Intergroup responses mandates if the motion will be discussed.

- The body held a formal poll to vote on NMB T
 - 17 out of 20 voters agreed to NOT send this item forward
- Christina D led discussion regarding NMB U and provided the first Pro statement regarding moving this item forward for discussion at WSBC.
 - Parliamentary procedure was followed. Timer was initiated and each speaker allowed 2 minutes for each Pro and each Con statement, alternating between pro and con for a total of three each. Questions were allowed after the pro/con statements.
 - The question asked prior to voting was for clarification on the rationale given by the maker of the motion. The question was answered to satisfy the asker.
 - The body held a formal poll to vote on NMB T
 - 13 out of 19 voters agreed to NOT send this item forward (one member had left the meeting prior to voting)

- NBM B: Consolidate the Public Communications Policy into one and rescind the 4 it replaces.

- NBM D: Remove the requirement for home addresses to be included in the contact report that is sent to delegates.

- NBM M Increases the cap on amount any one person can contribute in a year to \$7,500.
- NBM N Extends the time for report submission after Conference from 2 weeks to 4 weeks.
- NBM O Rescinds the policy to establish a Spanish Language Service board because all the work to make that possible has been completed.
- NBM P Rescind policy that led to update of Website. Work was completed and the Board has an established timetable for frequency of revising the website.
- NBM Q Remove the specifics of Google search from the policy.
- NBM R Removes the list from the Diverse Voices Policy. A list is more limiting that expansive, no list allows for things to be flexible.
- BPI 1 Establishing hybrid requirement for WSBC
- BPI 2 Update language around Conference Committee dissolution.
- BPI 3 Update definition of a group, to new service structure language.
- BPI--4 Remove the word Special when referring to Special Focus Service Boards
- BPI 5 Minor correction to special focus service board definition.
- BPI—6 Change the wording that indicates WSBC must be located in the USA.

- BPI -8 Remove the words other special and replace with additional as special in this instance is seen as offensive.
- BPI Update language on how Conference material is disseminated and that makes it seem like the conference is held in person.
- BPI -10 Clarifies who can submit motions. Removes the possibility of a single trustee from doing so.
- BPI -11 Another motion about hybrid conferences.
- BPI 13 Opens the possibility of choice for affiliation to National Service Boards and Regions
- BPI—16 Motion to clarify the assignment of Trustee Liaisons by the BOT.

The meeting centered around the Program of events. Jeremy and Susan reviewed the notes from the February 10 sub-committee meeting for program outline with everyone as some were not at the last meeting because of conflicting event planning.

Ideas discussed regarding the use of 4 speakers to lead 4 sessions:

- o Possibly use committee member(s) to open and close the retreat since we're creating the Program
- Speakers will be members attending the retreat and no compensation (registration) given for those speaking
 - Create a pricing option for members wanting to come for Saturday only that does not include room or meals
 - Be mindful of the ability to use We Care Funds for speakers in need of financial assistance
- Possibly use multiple speakers for each session
- Speaker could use 20-30 minutes for their experience on the topic then use the remaining time for the following:
 - Journaling
 - Ask-It Basket passed during the talk
 - Panel Discussion on the topic
 - Question/Answer time
- Allow each speaker to formulate their own layout of their time on the assigned topic
 - Committee member(s) to review the general information to be shared by each speaker in protection of attendees from hearing about a personal religion or other outside issue that may be triggering or exclusive
 - Committee to support activity developed by the speaker (i.e., making sure supplies are at hand such as paper, pens, crayons, craft materials, panel members, etc.)

Ideas discussed regarding the Topics for speakers

- o Move away from the use of "religion" in topics because of it being an outside issue by OA tradition
- o Open each speaker session regarding OA/AA statement on spirituality not being exclusive to anyone.

- Della suggested possibly using the declaration on spirituality used at the Webster Groves,
 Saturday am meeting
- J-MO suggested a quote taken from the OA Unity Within Diversity policy as follows:
 - "THE FELLOWSHIP of Overeaters Anonymous encourages and promotes acceptance and inclusivity. All are welcome to join OA and are not excluded because of race, creed, nationality, religion, gender identity, sexual orientation, or any other attribute. We welcome all who share our compulsion. Everyone with the desire to stop eating compulsively is welcome in Overeaters Anonymous."
- Spirituality topics
 - Friday: What is Spirituality-talking about the benefits and what spirituality is NOT
 - Saturday Morning: Using spiritual practice to heal: emotionally, spiritually, and physically
 - Saturday Afternoon: Using spiritual practice to find purpose and to walk through difficult times
 - Sunday Morning: Using spiritual practice to find gratitude and meaningful connections

Other ideas for Program stated by committee members

- Starting each morning with guided meditation, suggested Debbie K as leader either in person or recorded if she isn't attending the event
- Yoga practice that includes all members' capabilities-Della will have her certification by the event time and can lead in simple stretches for everyone
- o OA meetings tied to the topic of Spirituality leaders of each meeting may be committee members

Get OA's name out there in the early spring when people are likely to be looking for weight-loss and other relevant programs. Cover January and February, and as far into March as the funding will reach. Hope for 2,000 extra people to see our intergroup website stlouisoa.org.

The funding:

\$3,000 (\$1,000 budgeted and \$2,000 special allocation).

How it works:

The OA name and our intergroup information appears sometimes when people in our intergroup area do Google searches for subjects like "weight loss programs," "binge eating disorder" or "overeaters anonymous." When people click on our name, they come to our website stlouisoa.org.

The results:

In January 2023 our Google Search Ads provided 1,090 extra visitors to our website.

In February 2023 our Google Search Ads provided 978 extra visitors to our website.

So we have met our 2,000-visitor goal. We will continue the campaign through March 12, 2023.
