St. Louis Bi-State Intergroup Minutes Sunday, January 14, 2024 at 1:30 p.m.

Open: The meeting was called to order by Vice Chair, Elizabeth C. at 1:30 p.m. Zoom recording feature enabled for the duration of the meeting. All members were informed of the recording process.

Communications: Meeting was held via ZOOM. Members were instructed on meeting ID and Password via email. Representatives were notified via email of previous meeting minutes and committee/service reports prior to the meeting.

Readings: Serenity Prayer, The Twelve Steps, Tradition?, Concept?

Welcome: There were a total of 23 members in attendance: 13 IG Reps and 10 Service Board Members.

Minutes: November 12, 2023, minutes were distributed via email for review prior to the meeting. Amy G. noted that the minutes were correct as presented, but that after the November meeting a date change had occurred on the April Super Saturday. She asked that it be noted that the Super Saturday will be held on Saturday, April 20, not April 13th. Otherwise, the minutes were approved as corrected.

Reports: Chairperson and committee reports were distributed via email for review prior to the meeting. There were no additional questions regarding reports and no additional reports were given verbally.

Seventh Tradition and Roll Call: Not noted.

Intergroup Reps Home Meeting Comments: No comments were offered.

Old Business:

Dianne S. had an update on the timeline for our St. Louis IG to decide on our new Region affiliation. The deadline has changed, and we must now make our choice at the February IG meeting. Dianne reminded members that that Della and her committee distributed a wonderful chart, outlining the various regions, to help in our decision making. Time is of the essence for our individual meetings to have their Group Conscience and pick their desired region.

Dianne also gave us a brief history of why there are regions in OA and their importance. Region 4 is disbanding because of a persistent inability over the past five years to staff the various service positions effectively. It is important that we choose a region that will be the best fit for us so that we can continue the work of OA.

New Business:

1. Marina F. presented the 2024 IG Budget to the group. This is a balanced budget, that is, it is estimated that we will spend exactly the revenue we take in. Changes included a switch from QuickBooks to Excel Spreadsheets for simplicity, slight increases in some of our costs, a decrease in storage space costs, and an increase in marketing expenditures to cover Google Ads, and website costs that in years past, were covered by Region 4, but will now be under our purview, after the dissolution of Region 4.

The group held a discussion about whether their contributions to OA, which is a 501c(3), a recognized charitable organization, are tax-deductible. Yes, our donations are tax deductible, but of course, each member should maintain a record of their donations. Please consult your tax person for further assistance or questions. There was also discussion about the associated PayPal fees with each donation. Please encourage members in your groups, when making donations online, to make larger, infrequent contributions. For example, instead of a weekly donation of \$5, make a monthly or quarterly donation of \$20 or \$60. This helps reduce our PayPal fees.

- 2. Marina announced that St. Louis OA would be participating in a Holistic Health Fair in Effingham, Illinois on January 27th.
- 3. Cyndy L. presented information on the OA PSA and how we might want to get the PSAs to local media. The PSAs are already on our website and our Facebook page. Cyndy L. is asking that the board approve a contract with a small PR firm for less than \$500 to distribute the PSA to their media contacts. The plan was approved.
- 4. Eileen M, who sits on the Finance and Fundraising committee of Region 4, reminded us that there are funds available through Region 4 for marketing and PR efforts. She encouraged us to apply for those funds to help us with our PR efforts, including the above plan.
- 5. Elizabeth C. announced that help is needed to run the monthly Intergroup meetings, Volunteers are needed to be Zoom hosts and co-hosts, attendance takers, leaders, etc. Jane F, Della T, Eileen M, Amy G, Jessica B (Zoom host) volunteered.

Other Business

- 1. Marina showed us the monthly financial report that she gets from our bookkeeper. We will be seeing that each month.
- 2. Della asked the group if anyone had any plans for a possible Super Saturday for Unity Day the Early Bird group is interested. Della will get back to the group on that.
- 3. Cyndy L. would like the board to consider whether the Prudent Reserve is too high. Typically, the reserve covers approximately 3 months of expenses, but our expenses are so low now perhaps not that much needed.
- 4. Cyndy L. had a call to service for anyone who would like to submit ideas about the Joy of Service. Submissions are needed by February 15. The link can be found here: https://form.jotform.com/oaservicework/joy-of-service.
- 5. Marilyn thanked Della and her committee for the Region comparison chart. Very helpful.
- 6. Amy G. reminder that there is one final Region 4 convention June 14-15. Our IG is in charge of programming, and the committee is starting to work on that.

Website Report for St. Louis OA Intergroup

Reported Dates: January 2 – January 31, 2024

This is an interesting report because the huge increase in activity on our St. Louis website exactly corresponds to the Google ads that were begun January 2, 2024.

Feedback gained in a conversation with our co-chair and her Google ad contact revealed that we could have even more traffic on the site if we added more visuals to our website pages. As I've visited some other OA sites, I do see a similar "look" to ours, with a few more colorful icons on the pages.

Sessions: 3420 (this is a 928% increase over the previous 30 days)

Page Views: 4887 (this is a 553% increase over the previous 30 days)

New Visitors: 99%; Returning Visitors: 1%

Desktop/Tablet/Mobile: 9%/10%/79% (don't know why this doesn't add up to 100%--it's never happened before—perhaps some other type of device accessed the website outside these categories?)

The only decrease this month has been how long a person stays in the session: 14 seconds (68% decrease).
