

Intergroup Meeting Minutes Sunday, September 8, 2024

Open: The meeting was called to order by Chairperson Eileen M. at 1:30 p.m. Zoom recording feature was enabled for the duration of the meeting. All members were informed of the recording process.

Communications: The meeting was held via ZOOM. Members were instructed on the meeting ID and Password via email. Representatives were notified via email of previous meeting minutes and committee/service reports prior to the meeting.

Welcome: There were no new IG reps at the meeting.

Minutes: The minutes of the July 14 meeting were approved as submitted. The minutes of a special meeting of the Board, held August 25, were approved as corrected. An incorrect meeting date of July 14 was listed, instead of the actual date of the meeting.

Reports: There were no questions or comments regarding the various reports that were submitted to the trustees ahead of the meeting.

Seventh Tradition Collection: Our Treasurer has reminded us that since we are not meeting in person, IG Reps and the additional members who attend our IG meetings are asked to mail our IG meeting 7th Tradition donations to the IG mailing address (PO Box 28882, St Louis 63123-0082) or donate on the website (www.stlouisoa.org), via PayPal. Be sure to clearly mark that these are IG Meeting 7th Tradition contributions. Our group number is **09029**.

Roll Call: Amy G. took attendance at the meeting. Reps were asked to send any changes or updates to their contact information to info@stlouisoa.org.

Intergroup Reps: Bonnie asked that we double check the email address that we have listed for her. She is not getting any of the IG information. Martha said that she would follow up with her and help get it figured out.

Old Business:

- 7th Tradition clarification/update - Marina F., our treasurer, gave a very informative presentation about the 7th Tradition and how it applies to our IG meetings. A written copy of this presentation was distributed ahead of time in the Board packet. Marina gave us information on donating via PayPal and why it is both helpful and saves money (not only for IG but for the person donating) to make donations on a quarterly, semi-annual, or annual basis, versus monthly.
- Chairperson Eileen M. reminded everyone that we are accepting nominations for Intergroup Treasurer, Region 5 Representatives (2 open) and WSBC Delegate (1 open). Nominations for these positions must be received 15 days in advance of the meeting in which the election will be held or by Friday October 26 for the November 10 Annual Business Conference. The Treasurer position, in particular, is a crucial member of the board and although St. Louis OA IG employs a bookkeeper to help us with our payables and receivables, it is the job of the Treasurer to oversee these duties. Marina assured everyone that this is NOT a difficult job, that it is not overly time consuming and wanted to stress that as outgoing treasurer she would help the incoming person get familiar with the job, as would the other 3 members of the board. One year of abstinence is required.

Andrea asked if any of these positions remain vacant, particularly region or WSO positions, would it affect St. Louis OA in any way? Eileen replied that as far as the board position goes, whenever there is a vacancy on the board, the other board members must step up and assume the duties of the missing board member. The board can do that in the short run, but it is not ideal in the long run. As

far as Region or WSO, since we do still have representation on the region and world service level, St. Louis Bi-State OA will still be in the loop on news, updates, etc.

- Fall Retreat Committee Update - Dianne gave a report on behalf of Della and Bill. Planning is going well, and slots are filling up fast. There are no more single rooms available and, as of this writing, only 5 spots left if you want to share a room. Amy G. asked if a person wants to attend only on Saturday can they register at the door? No, if someone wants to attend for only one day they need to register ahead of time. There are space constraints in the meeting room, and we would not want someone to show up only to not be able to accommodate them.

New Business:

- Eileen gave a report on the special board meeting that was held on August 25. There are a few suggested changes to the Bylaws and the Policy and Procedure manual. Those proposed changes will be submitted to the board ahead of the Annual Business Conference in November.
- Eileen wanted to encourage all IG reps to talk to their respective group members about hosting a Super Saturday in the months that we have left in 2024 and looking ahead to 2025. A few event themes to keep in mind: IDEA Day (International Day of Experiencing Abstinence) in November; a Winter holiday booster in December; Unity Day in February; Sponsorship Day in August, as well as other topics a group may want to explore throughout the year. She also encouraged individual meeting groups to partner and host a joint event.
- The Saturday morning Step and Tradition Study meeting is participating in a recovery event on Saturday, September 22 from Noon-6 pm in Kirkwood Park. **"Recovery Fest 2024"** is an annual event that brings the 12-step recovery community together in one location. The Saturday morning group participated last year and felt that it was of tremendous benefit in reaching the still suffering compulsive eater. There are still a couple of 2-hour volunteer slots open, Eileen asked that if anyone was interested to reach out to her and sign up!

What needs to be announced in home meetings?

- Consider running for the Intergroup Board position of Treasurer in November: this vital position is open, and our current Treasurer will mentor the person coming into that role. We also need a World Service Business Conference Delegate and two Region 5 Representatives

St. Louis Bi-State Area Intergroup Board of Trustees Meeting

Sunday September 8, 2024 from 3:00-3:30 pm

In Attendance: Eileen M. Chair; Amy G. Vice Chair, Marina F. Treasurer, Martha P., Secretary.

Three items were discussed:

Recovery Fest Event – Eileen asked if the board would approve ordering 50 pieces of OA literature for distribution at the event. The board was in agreement to do this. The cost would be approximately \$125.

OA Cell Phone – an idea was presented to the board about switching from the current carrier (T-Mobile) to Consumer Cellular. The cost at CC is a fraction of the cost at T-Mobile (\$20 per month versus over \$60 per month). The board was very supportive of doing this. Eileen is going to reach out to Elizabeth C. and ask about the pros and cons of keeping a flip phone versus going to a Smartphone. It was generally agreed that the simpler the phone, the better. We only really make and receive calls. Eileen will handle the details with Consumer Cellular.

Update on Board Binders – There was an outstanding issue with the information that Martha had received from Elizabeth about our Microsoft account. When we started using MS we were still using the old bistate1oa@prodigy.net email address. That email platform no longer exists. We have taken steps with MS to get our email address updated. There is a 30-day freeze on the account right now, which will not create any issue as our subscription is current through the middle of next year and we have no need to access the account at this time. We should be hearing from Microsoft confirming that they have accepted the new email address by the first part of October.

In the meantime, Martha is going to distribute a binder to each board member. Marina and Amy asked that theirs be in an electronic version and Martha and Eileen prefer an actual binder. When the new Treasurer is seated Martha will ask which version they prefer.

Reports: Martha pointed out proposed changes to the Bylaws and the Policy and Procedure manual and asked that the IG reps please take those proposed changes back to their groups for discussion. We will vote on these proposed changes at the November Business Conference.

Seventh Tradition Collection - No report as the Treasurer was unable to attend.

Leonard asked us to update our email contact list and add his email address. Also, any changes to your group's meeting information may be e-mailed to info@stlouisoa.org.

Intergroup Reps: Any news or announcements from your group? How can we help your group?

Andrea from the Early Bird Group let everyone know that they will again host a Thanksgiving meeting. Look for information in the upcoming newsletter.

Marilyn from the Sunday afternoon Abstinence First meeting reported 2 newcomers to their meeting.

There was a discussion of the 7th tradition and where we are in donations. Generally, we are down in donations. Zoom meetings take away that "in your face" reminder of passing a basket around. Colleen brought up an interesting idea that she has seen at a meeting that she attends in the form of a QR code on the Zoom screen during a meeting to make it easy for people to follow the link and donate.

We also talked about keeping up the tradition of Gratitude Month, which is typically held the month of November where attendees at our individual meetings are encouraged to donate extra to IG in gratitude of their recovery. Martha is to send a follow-up email to the board members asking if there are any objections to adding a blurb to the newsletter and possibly even the website. Members are encouraged to announce this at their regular group meetings the month of November, as well.

Old Business:

- We are accepting nominations for Intergroup Treasurer, Region 5 Representatives (2 open) and WSBC Delegate (1 open). Nominations for these positions must be received 15 days in advance of the meeting in which the election will be held or by Friday October 26 for the November 10 Annual Business Conference.

New Business:

- Two Bylaws changes are proposed for the membership to decide at next month's Business Conference:

1. To come into compliance with Region 5 Bylaws requirements, adjust our bylaws so that the abstinence requirement for a Region 5 Rep is changed from 6 months to 1 year.
 2. Remove the maintenance of an office from the IG Powers & Duties section
- There are several changes to the Board of Trustees duties in the Policy & Procedure Manual which you received in the packet for today's meeting. These proposed changes are now incorporated into the Manual and have been highlighted. We will vote on these changes at the November Business Conference. A question was asked about the meaning of the "Ex-Officio" position on the board. The Ex-Officio board member is typically the past chairperson of the board who serves as a kind of consultant/coach to the new chairperson and the Board of Trustees.
